IN THE PAST YEAR, THE TIMKEN MUSEUM WAS VISITED BY 197,405 PEOPLE. IN AN EFFORT TO SERVE THE ENTIRE COMMUNITY AND ITS VISITORS, ADMISSION TO THE MUSEUM IS FREE OF CHARGE. ADDITIONALLY, A NUMBER OF EDUCATIONAL PROGRAMS AND SCHOLARLY EXHIBITIONS WERE PRESENTED IN AN EFFORT TO FURTHER THE KNOWLEDGE OF THE WORKS IN THE PUTNAM COLLECTION AND THE ARTISTS WHO CREATED THEM. MANY OF THESE PROGRAMS ARE ALSO OFFERED FREE OF CHARGE, INCLUDING: SPANISH LANGUAGE OUTREACH PROGRAM, SCHOOL PARTNERSHIP PROGRAM, LECTURE PROGRAM, AND VARIOUS EXHIBITIONS.

SINCE ITS INCEPTION IN 1997, THE TIMKEN'S ACCLAIMED OUTREACH ESPANOL PROGRAM HAS GAINED COMMUNITY-WIDE RECOGNITION AND BEEN A MODEL FOR OTHER MUSEUMS TO FOLLOW. OUTREACH ESPANOL TARGETS THE SPANISH-SPEAKING POPULATION IN BOTH SAN DIEGO AND BAJA CALIFORNIA, MEXICO, THROUGH EDUCATIONAL PROGRAMS IN SPANISH. OUTREACH ESPANOL BRINGS OVER 2000 STUDENTS ANNUALLY FROM SAN DIEGO, TIJUANA, AND ROSARITO-BASED SCHOOLS TO THE MUSEUM FOR A TOUR BY THE TIMKEN'S SPANISH-SPEAKING DOCENTS. THE PROGRAM ALSO SUPPLIES EDUCATORS WITH TEACHING MATERIALS TO ENHANCE THE STUDENTS' VISIT TO THE TIMKEN. THE MUSEUM HAS PUBLISHED A TEACHER'S GUIDE TO THE COLLECTION IN ENGLISH AND SPANISH AS WELL AS A BILINGUAL CHILDREN'S GALLERY GUIDE THAT DOUBLES AS A COLORING BOOK. SPANISH-LANGUAGE LECTURES FOR ADULTS ARE ALSO ORGANIZED THROUGH THE OUTREACH ESPANOL PROGRAM.
